Minutes of the Meeting

1. Call to Order

The meeting commenced at 3:28 p.m.

2. Confirmation of Previous Minutes

The minutes of the meeting held on 14 August 2025 were approved.

3. Matters Arising

a. Education Initiatives

- i. i. Social Media Campaign The Administrator/Analyst presented the October batch of posts, which were approved.
- ii. *Bill of Rights Training* The Secretariat provided an update on the BOR training. A draft storyboard has been produced and a prototype presented. The storyboard will be circulated for members' approval prior to arranging the audio recording.
- iii. School Visits No visits are currently scheduled. Contact has been made with John Gray High School (awaiting response) and Sharon Marie Martin Primary School (visit expected, date to be confirmed). The approach of engaging smaller groups, rather than full assemblies, will be maintained.

b. Migrants

- CILPA has circulated a call for pro bono attorneys for migrants; responses are pending.
- Legal Aid has been granted in at least one Detention Centre case.
- The Secretariat will meet again with CILAC, who have offered support later in the asylum process, as well as potential legal clinics and training sessions. A Zoom link will be circulated.
- CBC has provided updated migrant statistics and removed the interview questions of concern.

• As progress on legislative amendments and the new Detention Centre remains limited, the next quarterly meeting with CBC is scheduled for Q1 2026.

c. Prison Updates

- A follow-up letter was sent to the Ministry of District Administration & Home Affairs regarding the increase in prisoners with mental health conditions; response pending.
- A further prison visit will be arranged for early 2026 once new members join in October.

d. HRC Annual Report

The 2024 report has been finalized and approved. It will be sent to the ODG for tabling before Parliament.

e. Mental Health

No updates at this time.

f. Beneficial Ownership Register

A UK barrister has been engaged to provide an opinion on the potential public beneficial ownership register, considering both constitutional and Cayman-specific concerns. A report may be published later.
